#### ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF 610 SANDGRASS, LLC

These Articles of Amendment to the Articles of Organization of 610 Sandgrass, LLC, a Florida limited liability company (the "Company"), are executed by the undersigned authorized representative of the Company, for the purposes set forth herein.
