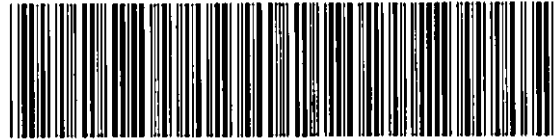



The name of the Limited Liability Company is "**Eisenfelder Investments, LLC**" (the "**Company**").


