SJR CAPITAL II, LLC, a Florida limited liability company, hereby presents these Articles of Dissolution evidencing the dissolution and discontinuation of business of SJR CAPITAL II, LLC, and sets forth the following pursuant to the provisions of Section 605.0707, *Florida Statutes*:

1. The name of the limited liability company is SJR CAPITAL II, LLC (the "LLC").
2. The Articles of Organization of the LLC were filed on April 25, 2018 and assigned document number L18000101397.
3. The dissolution was approved by the sole member of the LLC on April 23, 2020.
4. The effective date of the dissolution of the LLC shall be the date these Articles of Dissolution are filed with the Florida Department of State.
5. Pursuant to Section 605.0701(2), *Florida Statutes*, the occurrence of the event that resulted in the dissolution of the LLC was the vote of the sole member of the LLC to discontinue the operations of the LLC and to dissolve the LLC.
6. All debts, obligations and liabilities of the LLC have been paid or discharged.
7. All remaining property and assets have been distributed to the member.
8. There are no suits pending against the LLC in any court.

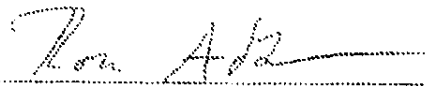
