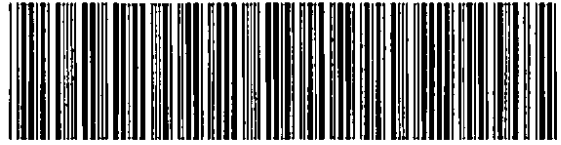


Article Four Management and Purpose


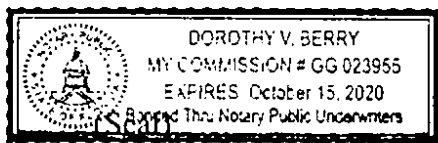


