TO
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **CAGI HOTEL SUPPLY, LLC** adopts the following Articles of Amendment to its Articles of Organization:

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on May 1, 2018, under Document Number L18000105393.


THIRD: The following amendment to the Articles of Organization was adopted by the Company:
