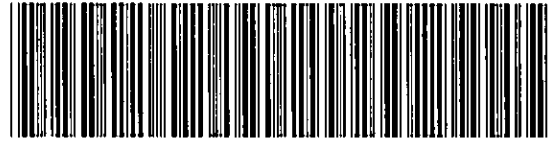

4. The date of filing of the dissolution of the Company is March 30, 2020.


