**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is **66ME, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

4. Management of the Company. The management of the Company shall be vested in the managers of the Company. The name and address of the initial manager of the Company is as follows:


