**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
COASTAL RISK MANAGEMENT, LLC**

These Articles of Amendment are filed pursuant to Section 605.0202, Florida Statutes, to reflect an amendment to the Articles of Organization of COASTAL RISK MANAGEMENT, LLC, a Florida limited liability company (the "Company"), which were originally filed on May 7, 2018. In connection therewith, the undersigned member, acting upon authority of the members of the Company, hereby sets forth as follows:

1. New Article VII is hereby added to the Articles of Organization, to immediately follow Article VI:

"ARTICLE VII – CAPITALIZATION

The maximum number of membership units which this company is authorized to have outstanding at any one time shall be Ten Thousand (10,000) voting membership units and Ninety Thousand (90,000) nonvoting membership units.

The relative rights, privileges, and limitations of the voting membership units and the nonvoting membership units shall be in all respects identical, unit for unit, except that the voting membership units shall entitle the holder thereof to one vote for each voting membership unit on all matters requiring the vote or approval of the members of the company and the holders of the nonvoting membership units shall not have any right or power to vote, unless otherwise required under state law."


2. The amendment contained in these Articles of Amendment was approved by the unanimous vote of the members of the company.

3. Upon the filing of these Articles of Amendment with the Department of State, this amendment shall become effective, and the Articles of Organization of COASTAL RISK MANAGEMENT, LLC shall be deemed to be amended accordingly.
