NAME**



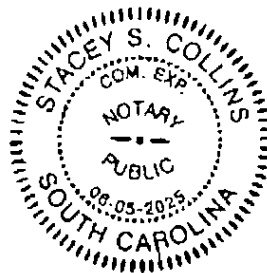


