5. **Management.** The Company shall be a manager-managed company. The name and address of the initial manager of the Company is:

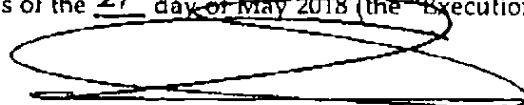

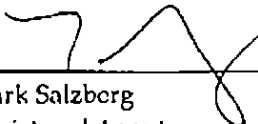
