A Florida Limited Liability Company

- Name. The name of this limited liability company is Staats Enterprises, LLC (the "Company"); and it shall be formed as a Florida limited liability company under Chapter 605, Florida Statutes.
- Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be pérpetual.
- Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
- Place of Business. The mailing address and street address of the Company's principal office is 3561 Pennyroyal Road, Port Charlotte, Florida 33953.
