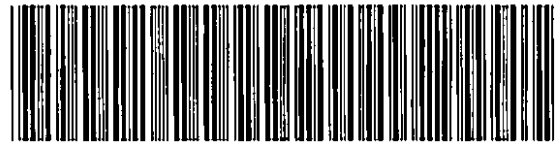

TRANSFERABILITY OF MEMBERS' INTEREST**


