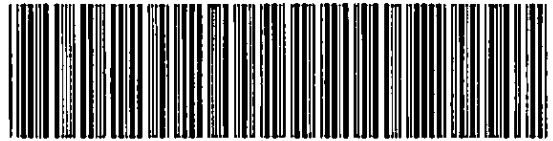

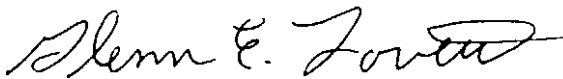

**ARTICLES OF ORGANIZATION
OF
CURRENT PRODUCTS COMPANY, LLC**

The undersigned, Willis J. Mullet, a natural person competent to contract and an authorized representative of Current Products Company, LLC, hereby presents these Articles of Organization as the Articles of Organization of Current Products Company, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Current Products Company, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

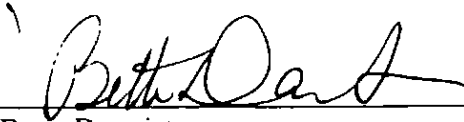
