ARTICLES OF ORGANIZATION OF HILL FARM HOLDINGS, LLC 18 APR 20 AM 11:

The undersigned certifies that he is acting as an authorized representative for the parpose of forming a limited liability company under the laws of the State of Florida providing for the formation, rights, privileges, and immunities of limited liability companies for profit. The undersigned further certifies that the following Articles shall serve as the charter and authority for the conduct of business of the limited liability company.

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be **HILL FARM HOLDINGS**, LLC and its principal office shall be located at 10 Hill Farm Way, Barkhamsted, Connecticut 06063, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate. The mailing address shall be the same.
