**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is VHU HOLDINGS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of May 18, 2018, and shall thereafter be perpetual.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 900 W. Platt Street, #100, Tampa, Florida 33606.




