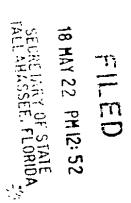

ARTICLES OF ORGANIZATION

<u>OF</u>

QUIS SERVICES, L.L.C.



The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be QUIS SERVICES, L.L.C. The street address of the principal office of the limited liability company in Florida shall be 2347 Bennett Road, Plant City, Florida 33565, and the mailing address shall be 2347 Bennett Road, Plant City, Florida 33565.

ARTICLE II - DURATION

The limited liability company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State.

<u>ARTICLE III - PURPOSES AND POWERS</u>

The specific purpose for which this limited liability company is organized is propane consulting and estimating. Each member shall make additional capital contributions to the limited liability sompany only upon the unanimous consent of all the members.

<u>ARTICLE VII - ADMISSION OF NEW MEMBERS</u>
