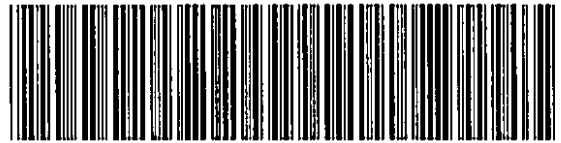



Pursuant to the provisions of Chapter 605, Florida Statutes, this limited liability company shall begin in existence upon the filing of these Articles of Organization.




