

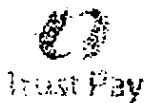




ARTICLE XI
