**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **CFO ADVANTAGE, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Revised Limited Liability Company Act, *Florida Statutes* § 605.0202:
