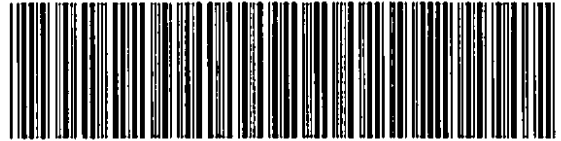

Pursuant to the provisions of Section 605.0202 of the Florida Statutes, the undersigned members of IT DOESN'T TAKE A HERO, LLC, a Florida limited liability company (the "**Company**"), whose Articles of Organization were originally filed with the Florida Department of State on May 25, 2018, document number L18000131110, hereby amends and restates its Articles of Organization in their entirety as provided below.

**ARTICLE I

NAME AND STREET ADDRESS OF REGISTERED AGENT**






