**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
SANTOS PRIMARY CARE MEDICAL CLINICS, PLLC**

Pursuant to the provisions of Section 605.0202, Florida Statutes, Santos Primary Care Medical Clinics, PLLC (the "**Limited Liability Company**"), does hereby certify:

I. The Limited Liability Company, pursuant to the provisions of Section 605.0202, Florida Statutes, hereby adopts these Amended and Restated Articles of Organization which replace the Articles of Organization filed with the Florida Department of State on May 25, 2018 under Document No. L18000131478.

II. These Amended and Restated Articles of Organization change the name of the Limited Liability Company, to designate a new registered agent and to make certain other changes, all as set forth in the Amended and Restated Articles of Organization.

III. These Amended and Restated Articles of Organization were unanimously approved by the members of the Limited Liability Company.

IV. Upon the effective date set forth herein, the Articles of Organization of the Limited Liability Company and all amendments and supplements thereto are hereby superseded and replaced in their entirety with the Amended and Restated Articles of Organization, which are as follows:

ARTICLE I - Name

No transfer of an Interest in the Limited Liability Company is permitted or valid except in accordance with the restrictions on transfer contained in the Operating Agreement of the Limited Liability Company, as amended at the effective time of the transfer.


