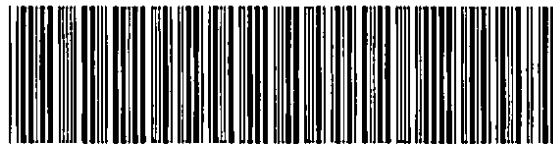


THIS IS TO CERTIFY THAT:
