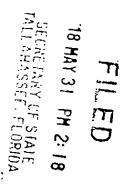

#### ARTICLE VII - MANAGEMENT

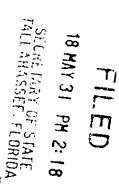
This Limited Liability Company shall be managed by a manager selected by a majority vote of its members.
