

ARTICLES OF ORGANIZATION OF GATOR SLAPPA HOLDINGS, LLC

The undersigned hereby submits these Articles of Organization (these "Articles of Organization") for the formation of Gator Slappa Holdings, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes.

ARTICLE I - Name

The name of the limited liability company is Gator Slappa Holdings, LLC (the "Company").

ARTICLE II - Address

The mailing and street address of the principal office of the Company is:

ARTICLE III - Duration

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of a written operating agreement of the Company, as the same may be amended from time to time (the "Operating Agreement").

ARTICLE IV - Management and Officers

The Company shall be manager-managed, with the Manager elected as described in the Operating Agreement. The initial manager of the Company (the "Manager") shall be as follows:

Unless a Statement of Denial has been filed by the Company, any officer of the Company shall be authorized to legally bind the Company and such authority shall be in addition to the signatory authority granted to the officers and to the Manager under the Operating Agreement or otherwise by operation of law, and the signature of either the Manager on designated officer shall be sufficient to bind the Company.

ARTICLE V - Admission of Additional Members

The Company shall admit new members only upon the unanimous written consent of all the then-existing member(s) of the Company or as otherwise provided in the Operating Agreement.
