1. Name. The name of the Limited Liability Company shall be JAX VET SURGERY, LLC.

2. Duration of Company. The company shall have perpetual duration.

3. Principal Office. The mailing address and street address of the principal office of the Limited Liability Company is 820 Baytree Lane Ponte Vedra Beach, Florida 32082.

4. Registered Agent and Office. The name and street address of the Limited Liability Company's initial registered agent is Kathleen H. Cold, One Independent Drive, Suite 2301, Jacksonville, Florida 32202.




