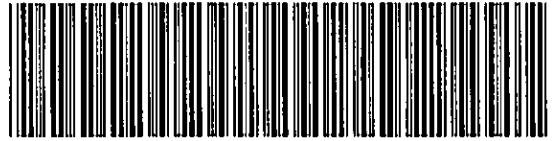


# ARTICLES OF ORGANIZATION FOR FLORIDAL LIMITED LIABILITY COMPANY

**ARTICLE I – Name:** The name of the Limited Liability Company is Willow Cay, LLC.


