

ARTICLES OF ORGANIZATION OF LYNN'S SOUTHERN TABLE, L.L.C.

- 1. <u>Name</u>. The name of the limited liability Company (hereinafter referred to as "Company") is: LYNN'S SOUTHERN TABLE, L.L.C.


