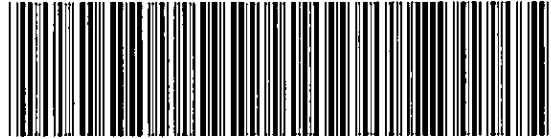



ARTICLES OF ORGANIZATION

ARTICLE IX - MANAGEMENT


The Company shall be member-managed in accordance with the Operating Agreement of the Company as adopted and agreed upon by the members.




