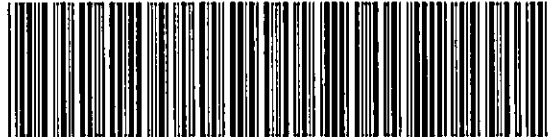

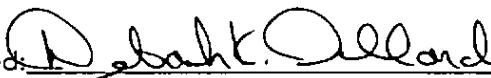
**ARTICLE III - CERTIFICATE OF DESIGNATION OF

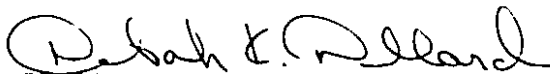
