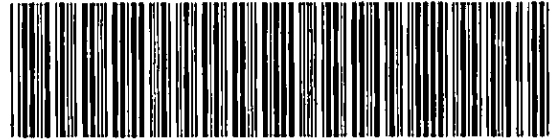

**ARTICLES OF ORGANIZATION
OF

The undersigned, in order to form a for profit company and pursuant to Chapter 605, Florida Statutes, hereby adopt the following Limited Liability Company Articles of Organization:

**ARTICLE I
Name and Principal Office**

The name of the limited liability company is **Stow-Away Storage, LLC** (the "Company"). The principal office and mailing address shall be located at: **2152 Brown Road, Ponce de Leon, Florida 32455**.

**ARTICLE II
Duration**

The Company shall have a perpetual duration.
