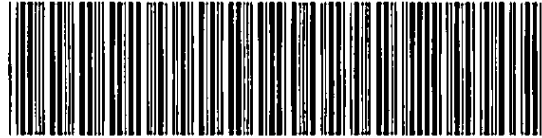

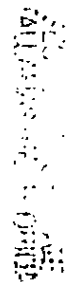

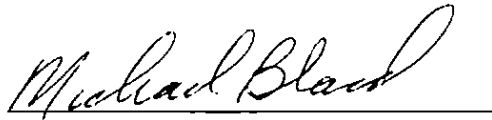
**ARTICLE IX**

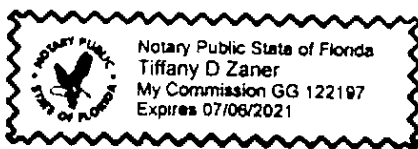

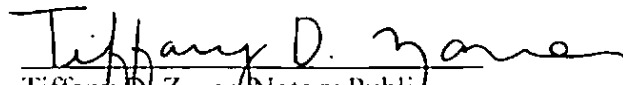
