

I hereby file these Articles of Organization for the professional limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

ARTICLE I

NAME

The name of the limited liability company to be formed hereunder is "DAVID T. KNIGHT LAW, PLLC" (the "Company").

ARTICLE II

DATE OF EXISTENCE AND PERIOD OF DURATION

The Company shall begin existence effective the 18th day of May, 2018, and shall continue until terminated in accordance with the Operating Agreement adopted by its member(s) (the "Operating Agreement").

The Company shall engage in the practice of law and shall have no other purpose except as permitted under the laws of the State of Florida.



New members may be admitted to the Company as provided in the Operating Agreement.



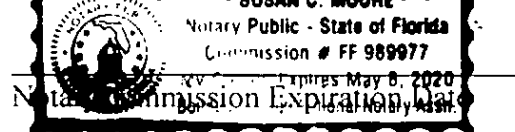
