FINAL JUDGMENT OF SIMPLIFIED DISSOLUTION OF MARRIAGE


THIS CASE came before the court on April 2, 2019, upon the parties' Petition for Simplified Dissolution of Marriage. The court, having reviewed the file and heard the testimony, finds and orders as follows:

- The court has jurisdiction over the subject matter and the parties. 1.
- 2. At least one party has been a resident of the State of Florida for more than six months immediately before filing the Petition for Simplified Dissolution of Marriage.
- The parties were married on April 30, 2016. The marriage between the parties 3. is irretrievably broken. Therefore, the marriage between the parties is dissolved, and the parties are restored to the status of being single.
- 4. The parties have no minor or dependent children in common and the wife is not pregnant.
- 5. There is no marital property or marital debts to divide, as the parties previously have divided all of their personal property. Therefore, each is awarded the personal property

he or she presently has in his or her possession. Each party will be responsible for any debts in his or her own name.

- 6. If necessary, each party must execute and deliver to the other party any documents that may be reasonably required to accomplish the intent of this judgment and must do all other things to such end. If either party fails to do so, then this judgment will have the effect of a duly executed instrument of conveyance, transfer, release, acquisition, or acquittance of property and/or assets as provided in Section 61.075(4), Florida Statutes, and Rule 1.570, Florida Rules of Civil Procedure.
 - 7. The wife's former name of Jeanette Ramirez is restored.
 - 8. The court reserves jurisdiction for all purposes.
