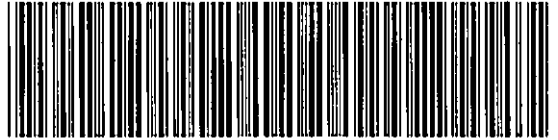

ARTICLE VI – AMENDMENT

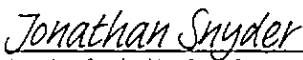

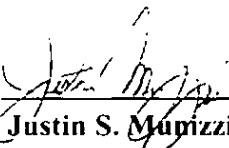
