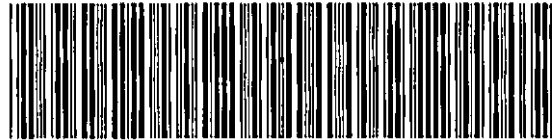

**ARTICLES OF ORGANIZATION
OF

The undersigned hereby adopts these Articles of Organization in order to form a limited company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes.

BUSINESS AND MAILING ADDRESS**



The members of the Company shall have the right to admit additional members on such terms and conditions as are provided in the Operating Agreement of the Company.


