

**ARTICLE IV – Management**

The Company shall be a manager-managed limited liability company. The initial manager shall be Daniel H. Sifrit and Melissa R. Sifrit, whose address is 25370 Palisade Road, Punta Gorda, Florida. The managers may act jointly or separately. Any subsequent manager or managers shall be appointed as provided in the Operating Agreement as it may be amended from time to time. The manager may appoint, employ, or otherwise contract with any persons for the transaction of the business of the Company or the performance of services for or on behalf of the Company, and the manager may delegate to any such person (who may be designated by the manager as an officer of the Company) such authority to act on behalf of the Company as the manager may from time to time deem appropriate.
