To whom it may concern,

This firm represents Christopher Stegner ("Mr. Stegner") and we are writing to you in connection with the rejection referenced above.

Today we spoke Mr. Tyrone Scott who requested that we send this letter to document that Mr. Stegner was the owner and sole Director for Very Big Things, Inc., a now dissolved Delaware Corporation.

An Application by Foreign Corporation for Authorization to Transact Business in Florida was filed on April 19, 2018, attached as Exhibit A. Shortly thereafter, the Delaware Corporation was dissolved, and Very Big Things, Inc. filed an Application by Foreign Corporation for Withdrawal of Authority to Transact Business or Conduct Affairs in Florida on May 3, 2018 (Document Number: F18000001853), attached as Exhibit B.

On June 7, 2018, Mr. Stegner submitted Articles of Organization for Very Big Things, LLC that was not filed.

On June 11, Mr. Stegner received a rejection notice citing a conflict with Document Number: W18000037246, which is a rejected filing for Very Big Things, Inc., letter number 180611120820-200314437142.

This letter shall serve as a notice that Mr. Stegner is the owner of both companies and that the rejected filing is the potential cause of the discrepancy. His request is that the Delaware Corporation, Very Big Things, Inc.'s rejected filing be abandoned, in order to move forward with processing filing for the Florida LLC under Document Number: W18000054248.
