The Company shall be a manager managed company. The name and address of the manager of the Company are:

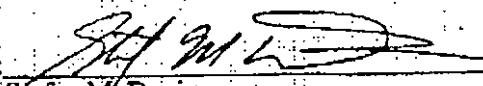
