ARTICLE 1 - NAME

ARTICLE 8 - TERMINATION OF EXISTENCE

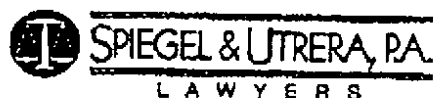




