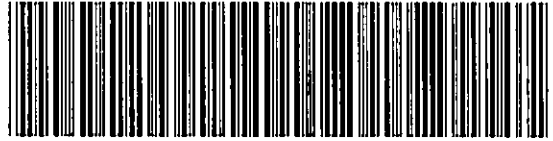

1. The name of the "Other Business Entity" immediately prior to the filing of the Articles of Conversion is **RGM PARTNERS** (the "Partnership"). The Other Business Entity (the Partnership) is a general partnership organized and formed under the laws of the State of Florida on August 21, 1989.
2. The name of the Florida limited liability company into which the Partnership is being converted, as set forth in the attached Articles of Organization, is **RGM PARTNERS, LLC** (the "Company").

5. The conversion of the Partnership into the Company shall be effective upon the date of filing of these Articles of Conversion.

No members of the Company are entitled to appraisal rights under §§605.1006 and 605.1061-605.1072, Florida Statutes, with respect to the conversion, but, to the extent that such appraisal rights exist, the Partnership has agreed, and does hereby agree, to pay any members having appraisal rights the amount to which such members are entitled under §§605.1006 and 605.1061-605.1072, Florida Statutes.


