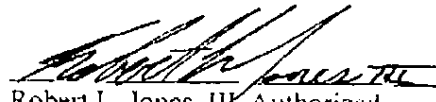
ARTICLE VII - Members

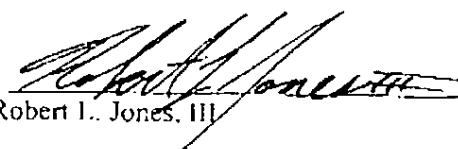
