ARTICLES OF ORGANIZATION
OF
CURMUDGEON HOLDINGS, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

ARTICLE I
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is CURMUDGEON HOLDINS, LLC.

ARTICLE II
ADDRESS

The Company's street address of its principal place of business in Florida is 2503 North 12th Avenue, Pensacola, Florida 32503, and its mailing address is 2503 North 12th Avenue, Pensacola, Florida 32503, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE III
MANAGEMENT

A member's interest in the Company may not be sold or otherwise transferred except with the unanimous written consent of all members and the Manager.
