## Articles of Organization

<u>of</u>

JOBB CROSS ST., LLC <u>A Florida Limited Liability Company</u> 1. <u>Name</u>. The name of this limited liability company is JOBB Cross St., LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 605 Florida Statutes under Chapter 605, Florida Statutes.

Duration. The Company shall exist from the date of filing of these Articles 2. of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

Purpose. The Company is organized for the purpose of transacting all 3. lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.

The mailing address and street address of the Place of Business. 4. Company's principal office is 714 Macedonia Drive, Punta Gorda, Florida 33950.

Registered Agent and Office. The name of the initial registered agent of 5. the Company is Michael M. Wilson. The street address of the initial registered agent of the Company is 17801 Murdock Circle, Suite A, Port Charlotte, Florida 33948.

Management of the Company. The Company shall be managed by a 6. manager or managers and is, therefore, a manager-managed company. Brian C. Helgemo and Bonnie Helgemo shall serve as the initial managers of the Company.

7. Additional Members. Except as otherwise provided in an Operating Agreement adopted for the Company, additional mombers to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought.

Operating Agreement. The members shall have the power to adopt, alter, 8. amend, or repeal an Operating Agreement for the Company containing provisions for the regulation and management of the affairs of the Company.

Voting. The Company is authorized to issue membership units with voting 9. rights and membership units without voting rights.

Certificated Interests. The members' interests in the Company may be 10. evidenced by certificates.

11. <u>Transfer of Interest</u>. Except as otherwise provided in an Operating Agreement adopted for the Company, no member shall have the right to transfer any interest in the Company without the unanimous written agreement of all members. If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring member shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

The undersigned executed these Articles of Organization effective as of June 20, 2018. In accordance with Section 605.0201, Florida Statutes, the execution of these Articles of Organization constitutes an affirmation under the penalties of perjury that the facts stated herein are true.
