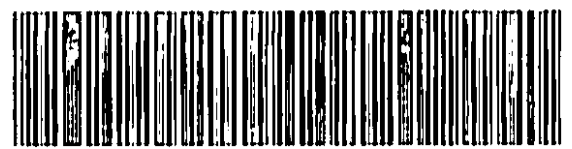

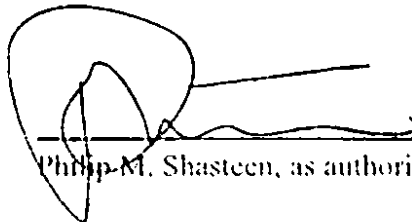

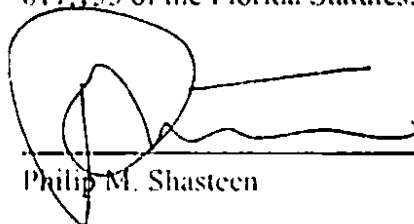
The Company will be managed by a Board of Directors appointed by its members as provided in the Company's Operating Agreement and by officers appointed by its Board of Directors.

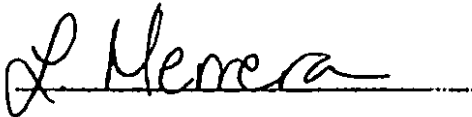
