The name of the limited liability company is: Ruby Street, LLC.

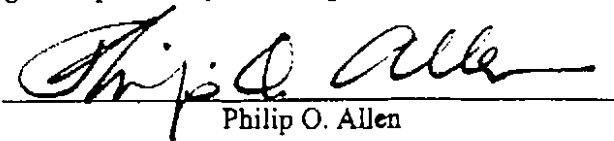
ARTICLE II. ADDRESS

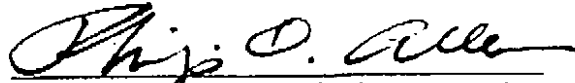

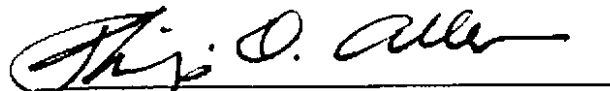
