

#### . ARTICLES AND CERTIFICATE OF CONVERSION OF SNAPPER CREEK NURSERY INC. WITH AND INTO SNAPPER CREEK NURSERY, LLC

This Articles and Certificate of Conversion (the "Articles of Conversion") and the attached Articles of Organization are submitted to convert SNAPPER CREEK NURSERY INC., a corporation organized under the laws of the State of Florida, into SNAPPER CREEK NURSERY, LLC, a limited liability company organized under the laws of the State of Florida, in accordance with Sections 607.1114 and 605.1045, Florida Statutes.

- 1. SNAPPER CREEK NURSERY INC., a corporation organized, and immediately prior to the filing of this Articles of Conversion, existing under the laws of the State of Florida was formed on April 17, 1987, under Document Number J68003.
- 2. The name of the Florida limited liability company into which SNAPPER CREEK NURSERY INC. will be converted is SNAPPER CREEK NURSERY, LLC. The Articles of Organization of SNAPPER CREEK NURSERY, LLC are attached to this Articles of Conversion.
- 3. The conversion of SNAPPER CREEK NURSERY INC., a Florida corporation, into SNAPPER CREEK NURSERY, LLC and the Articles of Conversion were approved by all of the shareholders and directors of SNAPPER CREEK NURSERY INC., in accordance with the provisions of Section 607.1112 of the Florida Business Corporation Act.
- 5. The address of the principal office of SNAPPER CREEK NURSERY, LLC is 31655 SW 117<sup>th</sup> Avenue, Miami, Florida 33033. In that this conversion complies with Section 368(a)(1)(F) of the Internal Revenue Code of 1986, as amended, the Federal employer identification number for SNAPPER CREEK NURSERY, LLC will be 59-2809798 which is the same Federal employer identification number of SNAPPER CREEK NURSERY INC.
