The initial members of the Company shall be **THOMAS F. FREEMAN, III** and **LINDA S. FREEMAN**.



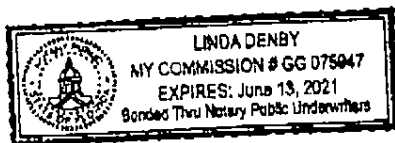


