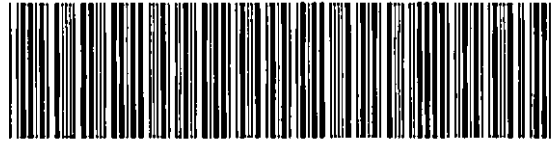

Duration

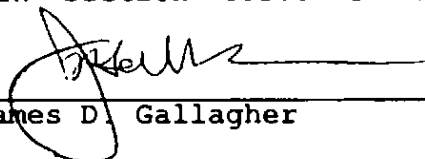

Members Rights to Continue Business

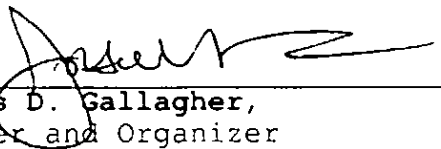
