**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION

Coccon Travel LLC, a limited liability company organized and existing under and by virtue of the provisions of the Florida Revised Limited Liability Company Act of the State of Florida does hereby certify:



Article IV. Transferability of Membership Interests

The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.

Article V. Distribution of Profits

Unless otherwise provided in the Company's Operating Agreement, there shall not be any distribution of profits unless each separate distribution is approved by the affirmative vote of members who own more than 50% of the voting interest in the Company. The voting members shall have complete discretion on when and if to approve any distribution of profits.


