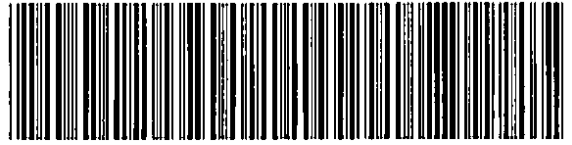

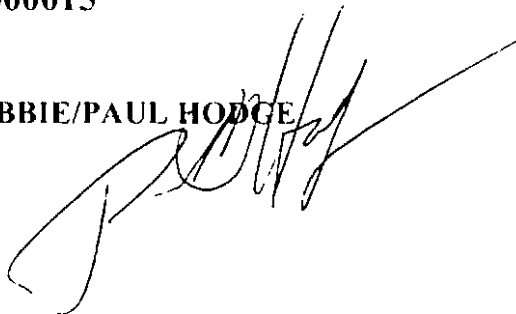

ARTICLE I — Name: The name of the Limited Liability Company (the "Company") is: NPB Hospitality, LLC

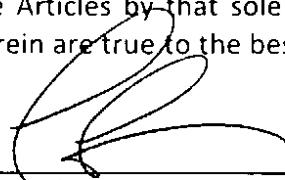

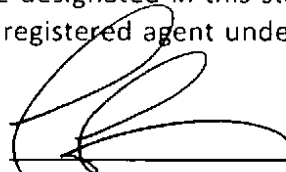
